
2. Selection of the nominee shall be based on the marks secured in PCB/PC Inter-Agri/PCM/PCMB in the Common University Entrance Test (CUET - UG) 2025.

3. All the intending candidates of the State Domicile may obtain the application form from the Department of Agriculture, Sanjenthong or download from the Department official website [agrimanipur.mn.gov.in](http://agrimanipur.mn.gov.in) and submit the duly filled application form along with self-attested copies of relevant document mentioned in the application form offline to the Directorate of Agriculture Sanjenthong / concerned District Agriculture Office of the district from 31<sup>st</sup> July 2025 (Thursday) to 8<sup>th</sup> August 2025 (Friday) by paying a registration fee of Rs.500/- for Gen/OBC candidates & Rs. 300/- for SC/ST/Third Gender/PwD.

4. For B.Sc. (Hons.) Community Science & B.Sc. (Hons.) Food Nutrition and Dietetics, only female candidate are eligible to apply.

5. For undergoing the above courses, candidates must score minimum 50% marks in aggregate of PCB/PCM/PCMB/Inter-Agri for General & OBC categories and 40% for SC/ST/PwD/Third gender/In-service categories in class 12<sup>th</sup> Board Examination/Inter-Agri.
